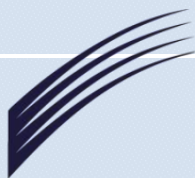

Identifying requirements of technical infrastructure for legally appropriate documentation of rights clearance activities (M1-M14)

- The working group members will identify requirements for a tool for legally appropriate documentation of rights clearance activities (of all kinds) taking into account frame conditions such as national laws and current state-of-the-art interfaces and platforms and compile those in a specification paper.

Scope and purposes

- literary works;
- documentation of the rights clearance processes (i.e. sources exploited, results, actions, follow-ups, etc.), incl.:
 - documentation of diligent search (OWs, OOC?)
 - licence management, incl. communication processes in case of agreements with authors or publishing houses, CC licences
 - supporting institutions in the field of OA communication
- providing solutions working in concordance with current library systems (ILS/LSP) – challenge: Work/Expression level?



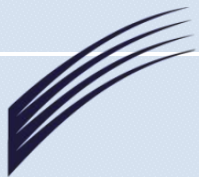

Information and Documentation —Presentation of Rights Information in Digital Collections

- in final draft phase

5.1: „Rights information to be presented is rights concerning the access and/or usage of the digital resource by the users. Typically, copyrights under the appropriate jurisdiction, agreements between stakeholders, and/or social customs are included.

Rights information should clearly state what users may do and may not do with the provided resource.”



ISO DTR 22038 – „Rights information elements”

- a) Type of the rights;
- b) Information to identify the rights holder:
 - name;
 - identifier;
 - contact information;
 - other details;
- c) Legal basis for the rights:
 - jurisdiction;
 - title of the law;
- d) Dates concerning the right:
 - copyright year;
 - other dates showing the effective term of the right;
- e) Permissions or licenses:
 - permissible actions;
 - prohibited actions;
 - conditions for the actions above;
 - patterned license name and/or link to the license;
- f) Other elements:
 - applicable legal instrument.



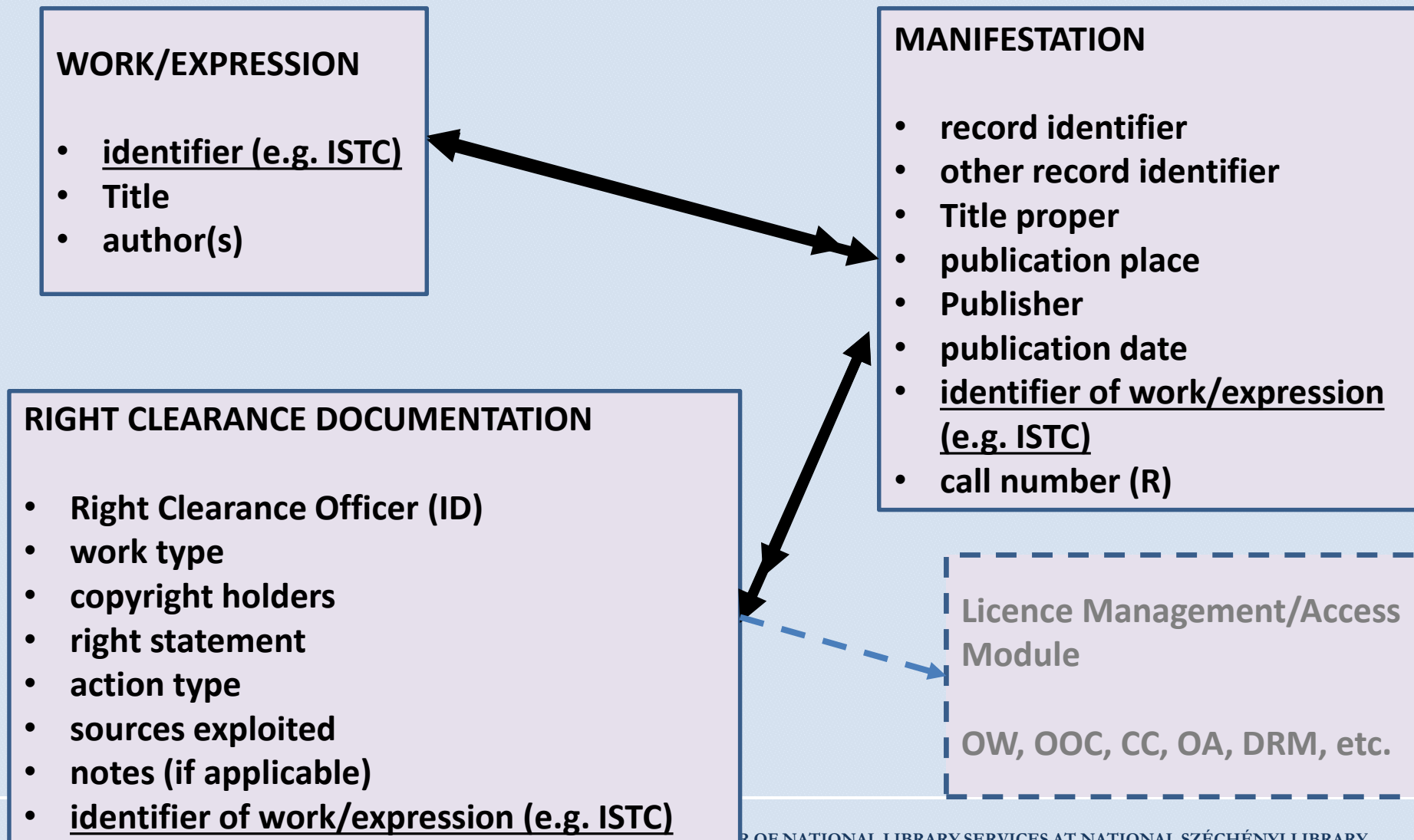

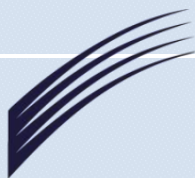

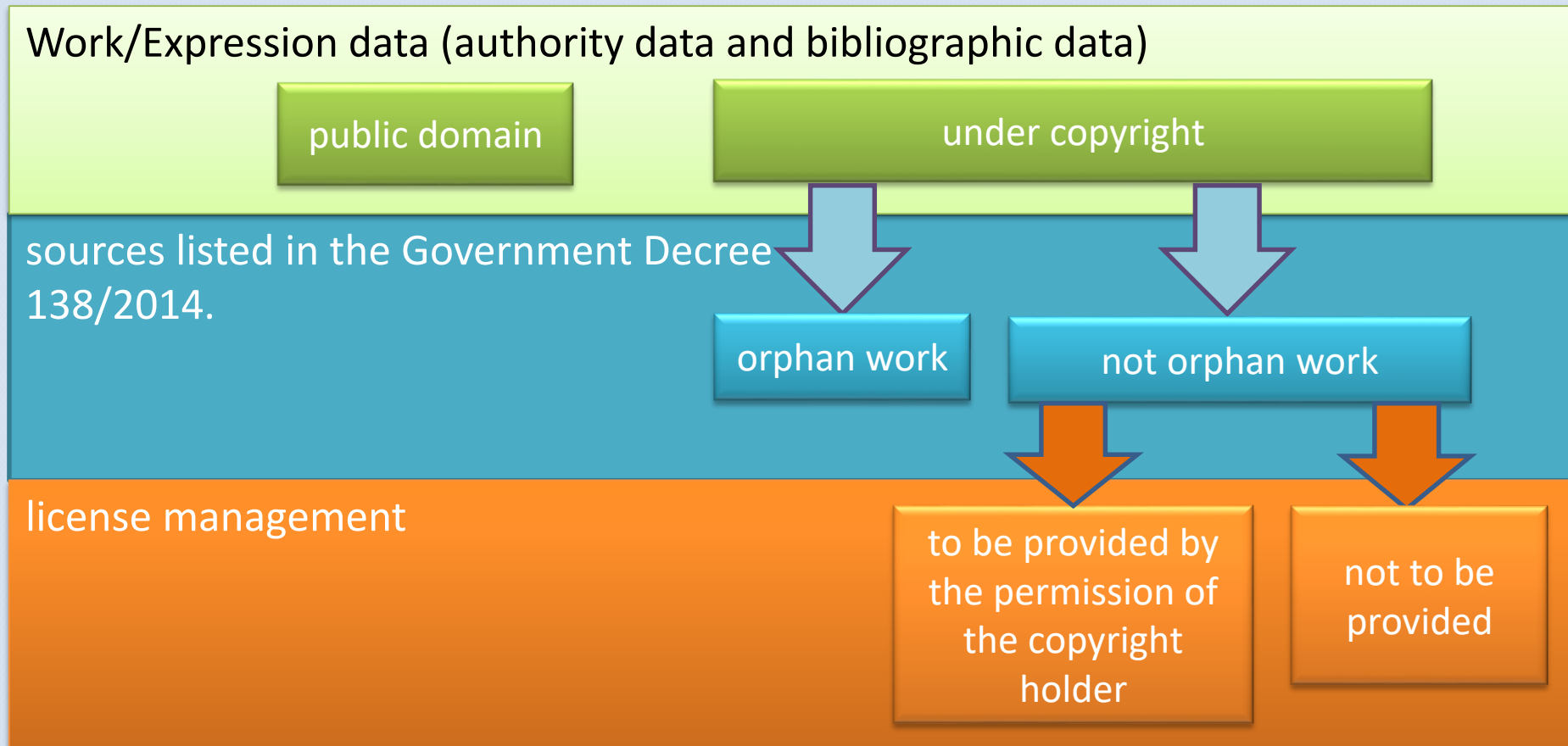

Access-module under development

- part of the new national library platform
- based on earlier developments
- cooperation with Books In Print company (data exchange in ONIX; opusnet.hu)
- using copyright statements (<https://rightsstatements.org/en/>) to be recorded in the field '506, in MARC 21; plus terms intended to use:
 - Public Domain – for documents published more than 140 years before the digitisation (to be automatically added to the records);
 - in copyright – freely usable (e.g. for preservation purposes); in copyright – freely usable (e.g. via access through dedicated terminal);
 - CC = Creative Commons (plus CC statements), etc.

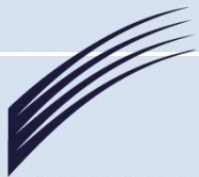


Next steps

identifying requirements

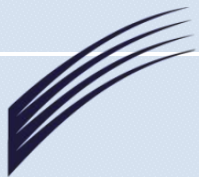
1. clarifying draft: compliance with national laws, current procedures/workflows or procedures/workflows intended to implement – 29 February 2020 – & see check list!
2. identifying technical solutions to apply: database, formats, vocabulary encoding scheme, interfaces, other standards, etc. – 14/15 May 2020

After that: D17 Specification paper 1 has to be done by 31 October 2020

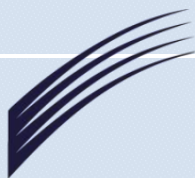


Check list
