

WG 6 Rights clearance documentation tool

Rights clearance is a substantial part of the work to be carried out when digitising 20th and 21st century literary works. However, no uniform tool or IT infrastructure exists to support the librarians in the important task of documentation of the rights clearance processes. These processes range from the documentation of the so called "diligent search" in case of orphan works or direct communication processes in case of agreements with authors or publishing houses to finally the back-and-forth communication in the process of supporting self-archiving deposits of researches at the own institution. Currently, all librarians are bound to "home grown" solutions and document their rights clearance activities and results in very different ways, e.g. on Excel sheets, Word documents, e-mail extracts. Most of them do not opt for long-term archiving and do not work in concordance with the libraries' central business and workflow systems/platforms, i.e. the integrated library system/library services platform. Thus, this working group will aim at developing tool(s) to support library staff in duly documenting the search and communication processes.

The National Széchényi Library of Hungary (OSZK, P12) will lead this working group and is responsible for the activities A17-A19 as described as follows which will be carried out in close cooperation with the partners P1 UIBK, P4 MZK, P5 UG, P6 NLS, P8 KNAV, P10 BNP, P11 NLE, P14 UREG and P15 VU.









Activity A17: Identifying requirements of technical infrastructure for legally appropriate documentation of rights clearance activities (M1-M26)

The working group members will identify requirements for a tool for legally appropriate documentation of rights clearance activities (of all kinds) taking into account frame conditions such as national laws and current state-of-theart interfaces and platforms and compile those in a specification paper.

Activity A18: Specifying requirements of implementation of rights clearance documentation tool into other workflows and environments (M27-M35)

The working group will specify the requirements of implementation of the rights clearance documentation tool into other workflows and environments such as the eBooks on Demand workflow, integrated library systems (ILS) and/or library services platforms, local library catalogues, union catalogues and other search tools for librarians.

Activity A19: Implementing and testing rights clearance documentation tool (M27-M60)

OSZK will implement the technical infrastructure as described in the specification papers D17 and D18. After the first successful tests within the infrastructure of working group members only, then the infrastructure will be tested with libraries from outside the project consortium (e.g. FOLIO/OLE community). The final aim of this activity is to provide the rights clearance documentation tool for reuse by any interested library as source code under an open source license as well as a ready-to-use web-service module for upcoming next-generation library systems such as FOLIO.

D19 Trial Implementations (M42, M60)

Deadline: 31.10.2024











All activities will be carried out in close cooperation with the WG 5 "Rights clearance and assessment support".

The requirements collected in WG5 will be used for A18.

The trial implementations from A19 will be tested in A15 and considered in best practice examples and scenarios in A16.
