



# **Workflow Dashboard elements 2**

# **Relevant regulations in the law**

#### General:

Section 31 (1) Copyright shall subsist <u>during the lifetime of the author and for</u> <u>seventy years following the author's death</u>.

(2) The seventy years' term of protection shall be calculated from the first day of the year following the death of the author and, for works of joint authorship, from the first day of the year following the death of the joint author who died last.

Special cases:

(3) If the <u>author cannot be identified</u>, the term of protection shall be seventy years counted from the first day of the year following the year in which the work was first published. If the author presents himself during this period, the term of protection shall be calculated pursuant to paragraph (2).
[(4) In the case of a <u>work made public in instalments</u>, the year of first publication shall be calculated separately for each part.]

# **Workflow Dashboard elements 3**

(5) The term of protection of a <u>collectively created</u> <u>work</u> shall be seventy years, calculated from the first day of the year following the first publication of the work.

[...]

[(7) If the term of protection is to be calculated from a date other than the first day of the year following the death of the author or joint author who died last, and the **work** is **not made public within the seventy year period following its creation**, the work shall not enjoy copyright protection.

Section 32 The person lawfully publishing a <u>work yet unpublished after the expiry of the</u> <u>term of protection or the period of time determined in section 31(7)</u> shall be entitled to legal protection equal to that of the economic rights of the author. The term of such protection shall be <u>twenty-five years</u> from the first day of the year following the year in which the work was first published.]

# Adjusting D17

### modification in workflow:

- inserting a ,0' step for dowloading/typing initial (bibliographic) metadata
- 3. querying EUIPO database  $\rightarrow$ 
  - 3.1 querying EUIPO OOC database;
  - 3.2 querying EUIPO OW database;
- 12. ask permission from right holder(s) to make the work available → instead → 10. licensing management

### defining new fields:

- published/unpublished
- illustrated/non-illustrated  $\rightarrow$

- visual artworks are subject to extended collective management
- information on being illustrated is relevant at each cases when a literary work was published less than 140 years ago → royalty is planned to be calculated according to the number of illustrated works on a flat rate basis

# **Open up activity content - Activity A16**

- **Clearing right**, developing best practice guidelines for IPR clearance and instructional material (M19-M54)
- Main goal of this activity is to prepare instructional materials for the use in member libraries as well as libraries outside the consortium in order to promote long-term IPR policy solutions and further network-building for realization of the policy. In this context, scenarios for use cases in four main areas (research, learning, leisure and creative industries) as well as best practice model contracts for pan-European access, open or restricted access and finally best practice workflow for clearing rights, digitisation and making available of 20th and 21st century literary works will be developed.

D16a Scenarios for use cases in research, learning, leisure and creative industries (M32)

- D16b Best practice model contracts for pan-European access (M50)
- D16c Best practice models for open or restricted access (M50)
- D16d **Best practice workflow for clearing rights**, digitisation and making available of 20th and 21st century literary works (M50)
